



Prof Frans Viljoen

Prof Viljoen is Direkteur van die Sentrum vir Menseregte in die Fakulteit Regsgeleerdheid. Sy navorsingsterrein is internasionale menseregte, met die klem op die regionale stelsel van menseregte in Afrika wat onder die vleuels van die Afrika-unie ingestel is. Prof Viljoen is reeds geruime tyd betrokke by voorspraak en opleiding in verband met die regionale stelsel van menseregte in Afrika en het wyd gepubliseer oor die internasionale reg van menseregte, met inbegrip van sy werk, *International human rights law in Africa* (Oxford University Press, tweede uitgawe, 2012).

Hy is hoofredakteur van die *African Human Rights Law Journal* en mederedakteur van die Engelse en Franse uitgawes van *African Human Rights Law Reports*. Prof Viljoen is ook akademiese koördineerder van die LLM in Menseregte en Demokrasisering in Afrika, wat deur die Sentrum aangebied word in samewerking met 12 regs fakulteite van oral in Afrika, wat in vennootskap met die Sentrum is. In 2012 het die Sentrum die Menseregteprys van die Afrika-unie se Kommissie vir Mense- en Volkereregte ontvang. Prof Viljoen het 'n B1-gradering van die NNS ontvang.

Prof Viljoen is Director of the Centre for Human Rights in the Faculty of Law. His research area is international human rights law, with a focus on the African regional human rights system, established under the auspices of the African Union. Prof Viljoen has been involved in advocacy and training on the African regional human rights system, and published widely on international human rights law, including *International human rights law in Africa* (Oxford University Press, second edition, 2012).

He is editor-in-chief of the *African Human Rights Law Journal* and co-editor of the English and French versions of the *African Human Rights Law Reports*. Prof Viljoen is also the academic coordinator of the LLM (Human Rights and Democratisation in Africa), presented by the Centre in collaboration with 12 partner law faculties across Africa. In 2012, the Centre received the Human Rights Prize of the African Union's Commission on Human and Peoples' Rights. Prof Viljoen holds a B1-rating from the NRF.
