**Research and Publications**

In March the Royal Institute of International Affairs at Chatham House in London hosted the launch of Prof Nathan's book, *Community of Insecurity: SADC's Struggle for Peace and Security in Southern Africa* (Ashgate 2012). The journal *African Security Review* is preparing to publish a symposium on the book.

Prof Nathan's article entitled 'The intelligence requirement of international mediation' has been accepted for publication in *Intelligence and National Security*, the leading international journal on intelligence.

Dr Odendaal authored a chapter, 'South Africa's infrastructure for peace', in Christopher Mitchell and Landon Hancock (eds), *Local Peacebuilding and National Peace: Interaction between Grassroots and Elite Processes* (Continuum 2012).

## Teaching

Prof Nathan presented for the first time a course on international mediation as part of the Honours programme offered by the Department of Political Sciences at the University of Pretoria. Twenty-two students registered for this course.

Prof Nathan presented a short course on international mediation to LLM students, Centre for Human Rights, University of Pretoria.

In April Prof Nathan presented his course on Managing Intelligence Reform, which is a component of the Masters in Security Sector Management offered by Cranfield University in the United Kingdom, at the Ethiopian Defence College in Addis Ababa.

In the second semester Prof Nathan presented his annual Hons/Masters course on Understanding and Managing Conflict at the University of Cape Town.

## Workshops

In April the Centre, in collaboration with the UN Mediation Support Unit, organised a consultative workshop on international mediation. The Ministerial Committee of the SADC Organ on Politics, Defence and Security Cooperation has asked the Centre to organise a mediation training workshop for officials from SADC states. The workshop is scheduled to take place in October 2012.

## Facilitation and Support

In March Dr Nyathi and Dr Odendaal facilitated a national consultation in Malawi on the establishment of an infrastructure for dialogue and collaborative problem-solving.

In May Prof Nathan was a facilitator at the Workshop on Exchange of Views between States Engaged in Mediation, Swiss Federal Department of Foreign Affairs, Berne.

In July Prof Nathan was the facilitator of the Retreat on Challenges to Peace and Security in Southern Africa, convened by the UN Department of Political Affairs in Pretoria. He was also a resource person at the UNDP workshop on Supporting the Iraq Defence and Security Community, held in Istanbul.

In July Dr Nyathi served as resource person for a South African civil society national dialogue initiative entitled 'Finding Ways to Walk Together'.

Throughout the reporting period Dr. Nyathi continued to serve as the Senior Reconciliation and Dialogue Advisor for the Organ on National Healing, Reconciliation and Integration in Zimbabwe. His support led to the Zimbabwe Cabinet's approval of the policy document on the establishment of the National Peace and Reconciliation Council.
