#### Faculty of Law hosts Society of Teachers of Law conference

The University celebrates its centenary in 2008 with the theme A century in the service of knowledge. The centenary starts officially with the University's birthday celebrations on 8 February 2008 and ends with the Laureate Ball on 15 November 2008. While the University commemorates its centenary, the Faculty of Law celebrates its 90th birthday in 2008. As part of the centenary and 90 year celebrations, the Faculty will host the Law Teachers' Conference; a Prestige Lecture Series by Judges; a Birthday Ball for staff, students and alumni; the African Human Rights Moot Court Competition; the 5th Annual Trade Moot; and the Faculty Cultural Festival.

One of the flagship events, the Society of Teachers of Law of Southern Africa (STLSA) Conference, will take place from 21 to 24 January 2008. The conference offers an ideal forum to discuss some of the most recent developments in all fields of law. Although the primary theme of the conference is the Harmonisation of Law in Africa and the challenges that globalisation and the need for closer regional co-operation pose for the law, there will be discussions on a diversity of topics on almost all aspects

of the law. Selected conference papers will be published in the accredited journal, De Jure.

The convenors of the conference have included workshops on class actions and legal education and skills as well as a panel discussion on the future of family law. Other sessions included in the programme canvass the Civil Unions Bill, Labour Law, Child Law, Consumer Protection Law; Therapeutic Jurisprudence; Clinical Law; Jurisprudence; Constitutional Law; Human Rights Law and many more. The number of sessions has been reduced from previous years so as to make each session longer and thus optimize the opportunity for meaningful discussions. A new presenters' session has been included in the programme where three young academics will make presentations and compete for a book prize sponsored by Oxford University Press.

Speakers will include such legal luminaries as Judge Edwin Cameron, Sir Bob Hepple and Prof David Pugsley. Other speakers come from Australia, Puerto Rico, Mauritius, Swaziland and Lesotho.

'The Law Teachers Conference will also give delegates the opportunity to meet old friends and make acquaintances in an academic environment' says Prof Caroline Nicholson, Head of the Department of Legal History, Comparative Law and Legal Philosophy, who is the organiser of the Conference.

In the tradition of the STLSA conferences, delegates can look forward to a full programme that includes exciting entertainment. The President of the Pan African Parliament has been invited to appear as a guest speaker at the cocktail function; delegates will enjoy an informal braai sponsored by LexisNexis, at which guests will be treated to jazz music, and a formal gala dinner sponsored by Juta.

### 'Ons taak is om afgeronde regsgeleerdes

aan die professie te lewer'

Prof Trynie Davel is aangestel as die Hoof van die Departement Privaatreg. Sy is sedert 1 Januarie 1980 'n dosent in dié Departement.

Prof Davel is vanaf die stigting van die Sentrum vir Kinderreg die Direkteur daarvan. Sedertdien het die Sentrum gevorder van 'n eenheid wat op navorsing en die uitbou van die vakgebied Kinderreg fokus, tot 'n gespesialiseerde regskliniek wat met behulp van litigasie in die openbare belang kinderregte daadwerklik bevorder.

Wat haar betref, is die Fakulteit Regsgeleerdheid in 'n opwindende fase, omdat die Fakulteit met die oog op internasionale erkenning en mededingendheid geposisioneer word. 'Die kerntaak van die Fakulteit Regsgeleerdheid is om afgeronde regsgeleerdes aan die professie te lewer wat trustees van geregtigheid en ambassadeurs van die Fakulteit sal wees."

Prof Davel beskik oor uitgebreide doseerervaring, maar op die oomblik spesialiseer sy in veral Kinderreg, Deliktereg en Skadevergoedingsreg. Sy het reeds vier doktorale kandidate afgelewer en 'n verdere sewe studente voltooi op die oomblik hulle proefskrifte onder haar leiding. Twee verhandelingstudente het die LLM-graad onder haar voltooi en sy is ook die koördineerder van die gedoseerde LLM-program in Kinderreg. Sy is die mede-outeur van 'n standaardhandboek oor die Personereg, die redakteur, outeur en/of mede-outeur van sewe ander boeke, nege hoofstukke in boeke en 33 artikels en vonnisbesprekings. Sy het reeds twee keer die Uitnemende Presteerder-toekenning van die Universiteit ontvang.

#### New Head for Mercantile Law

Prof Stefan van Eck was appointed as Head of the Department of Mercantile Law. He joined the Department of Mercantile Law in 1988 as an Academic Assistant. Il became a member of the Department to further my post-graduate studies, but became so attached to teaching and the academic environment that I decided to make it my career', he remarks.

Being the biggest department in the Faculty, it became clear to him that if teaching and research fare well within the Department of Mercantile

Law, it normally augers well for the Faculty as a whole. The Department currently has among its faculty members nationally recognised authors, opinion formers in their fields of expertise, researchers, editors and teachers who are acknowledged on a regular basis as lecturer of the year.

Prof van Eck views the students of the Faculty of Law as a pool of human capital that will soon make a contribution to the broader South African society. 'We do not only train prosecutors, attorneys, advocates, magistrates and judges - we also prepare well-rounded young people who will shape the country in the fields of commerce, politics and government. It is exciting to meet former students and hear about the progress they have made after they left the University,' he says.

Having completed his doctoral thesis in the area of labour dispute resolution. in 1993, he served articles at the University of Pretoria Legal Aid Clinic and was admitted as an attorney during 1997.

Prof van Eck has participated in research and teaching assignments in Australia, the USA, Spain and France. He sees his recent lectures at the University of Paris (Sorbonne Campus) during September 2007, as one of the highlights of his teaching career. Apart from serving as co-author with Prof Fanie van Jaarsveld of Principles of Labour Law and Kompendium van Arbeidsreg, he has also contributed chapters to international publications such as International Insolvency Law: Themes and Perspectives (Ashgate Publishers) and Legal Protection of Worker's Human Rights: Regulatory Changes and Challenges (Hart Publishers), due for publication

Prof van Eck's outside interests include cycling, canoeing and travelling. He hopes to participate in his 8th Cape Argus Cycle Tour in March 2008.

## 'The challenge is to find the balance between maintenance and innovation'

Prof Frans Viljoen

Prof Frans Viljoen was appointed as the new Director of the Centre for Human Rights

human rights law. He has also conducted research for the United Nations, the African Union, and non-governmental organisations, and is editor-inchief of the African Human Rights Law Journal and co-editor of the English and French versions of the African Human Rights Law Reports. He recently published a monograph, entitled International human rights law in Africa, with Oxford University Press.

He has visited 40 of the 53 African countries and his working knowledge of French is an asset in establishing and maintaining contact with many of the Centre's partners in Africa.

Having been involved in two programmes at the Centre for Human Rights, from their inception, Frans is aware that merely maintaining the current momentum and standards is a significant challenge. According to him: "It is important to ensure that these programmes are further supported and strengthened, not only to ensure their survival, but also their growth. However, the greatest challenge is to build innovatively on past accomplishments, and to establish the Centre as a research institution that responds to the burning issues of our time."

Prof Vitjoen obtained the degrees LLB, MA (in Afrikaans literature) and LLD (on the African regional human rights system) from the University of Pretoria and the degree LLM from Cambridge University. His doctorate, entitled The realisation of human rights in Africa through inter-governmental institutions, awarded in 1998, is squarely focused on the main research and teaching concerns of the Centre, for Human Rights.

Since its inception in 2000, Prof Viljoen has been the academic co-ordinator of the LLM (Human Rights and Democratisation in Africa) programme, presented by the Centre in collaboration with seven partner law faculties across Africa.

Prof Viljoen received a National Research Foundation (NRF) rating of 'B2' and has published numerous articles and other contributions in the field of international human rights law, and more specifically, African

#### **UNESCO** award for Centre for Human Rights

On Africa Day, 25 May 2007, the Centre for Human Rights was awarded the 2006 UNESCO Prize for Human Rights Education. The ceremony, which was attended by over 200 invited guests, was held in the Auditorium of the Faculty of Law. The keynote address was delivered by Deputy Minister of Education of South Africa, Mr Enver Surty.

The announcement of the award was made in Paris on International Human Rights Day, 10 December 2006, by the Director-General of the United Nations Educational, Scientific and Cultural Organization (UNESCO), Mr Kiochiro Matsuura.

Prof Neo Mathabe, Chairperson of the South African National Commission for UNESCO, congratulated the Centre on behalf of the South African UNESCO office. She was followed by Prof Calie Pistorius, Vice Chancellor and Principal, who emphasised that the Centre is a symbol of excellence to which the University aspires.

In a recorded message, UNESCO Director-General, Mr Matsuura, said that the award recognised 'the Centre's active participation in the construction of a democratic, apartheid-free society in South Africa and its significant contribution to the building of a culture of human rights by means of education and training in South Africa and on the African continent'.

The Chairperson of the International Jury of the UNESCO Prize, Prof Abdelfatah Amor of Tunisia, who also attended the ceremony, said that in deciding in favour of the Centre, the Jury wished to 'pay tribute to an institution that made remarkable efforts to build and consolidate a democratic, apartheid-free society in a country that suffered for so long from this scourge.'

In accepting the award Prof Christof Heyns, former Director of the Centre for Human Rights, paid tribute to his colleagues who have built the Centre over many years, and in particular to his predecessor, the former Director of the Centre for Human Rights, Justice Johann van die Westhuizen of the Constitutional Court.



Hanri received colours for netball while Gert-Andries was awarded colours for rugby.



#### Internationalisation

#### Taking Pretoria to the world and bringing the world to Pretoria

'Internationalisation in the Faculty of Law involves taking Pretoria to the world and bringing the world to Pretoria' says Prof Christof Heyns, Dean of the Faculty of Law.

Internationalisation in the Faculty is driven by the Internationalisation Committee with Prof Anton van der Linde from the Department of Private Law as Chairperson. 'The Faculty intends to capitalise on its leading position in Africa and its network on the continent, but does not focus on Africa exclusively', says Prof van der Linde.

In terms of existing exchange programmes with overseas universities, 11 international students participated in the LLB programme at the Faculty. They were also actively involved in day to day student life. One of our students, Riëtte Meyer, participated in the exchange programme at the Freij Universiteit in Amsterdam. Several lecturers of the Faculty visited our overseas partners for the purpose of teaching, conducting research and attending conferences.

The Faculty presents the LLM in Human Rights and Democratisation in Africa through the Centre for Human Rights, which involves a partnership between our Faculty and several African Universities.

Many Faculty members were elected to international bodies and committees, for example the International Bar Association. Staff members are encouraged to deliver papers at international conferences and to focus on international publications. From time to time members of the Faculty act as external evaluators with regard to LLB programmes at other African universities.

#### 3rd-year LLB student in exchange programme in Netherlands

Riëtte Meyer, a 3rd-year LLB student, was part of an exchange programme at the Freij Universiteit, Amsterdam, in The Netherlands. The programme consisted of three electives for her final year LLB.

Since the policy in The Netherlands is that up to 40 per cent of students attending universities should be exchange students from other countries, Riëtte was one of a few hundred exchange students from all over the world. 'Not only did I get the opportunity to become friends with people from different backgrounds and cultures, but in our courses the lecturers focused on the different legal systems represented by the students in our class', she said.

Riëtte also mentioned that the programme was not only a great opportunity to study principles not covered in any undergraduate law course in South Africa, but that she benefited from the experience of writing academic papers, and of doing oral and take-home examinations.

#### Loretta Feris appointed as international advisor on UNEP programmes

Prof Loretta Feris from the Department of Public Law was invited by the United Nations Environment Programme (UNEP) to act as an international advisor to governments on the UNEP Programme for the Development and Periodic Review of Environmental Law for the First Decade of the Twenty-first Century (Montevideo Programme).

These programmes were instrumental in providing UNEP with strategic guidance in addressing key environmental concerns through the development of new treaties and other soft law instruments. As a result of the Montevideo Programmes, legal instruments are developed to address issues such as biodiversity protection and ozone depletion.

Prof Feris attended a meeting in Geneva, Switzerland, to which 15 experts from around the world

were invited to review the implementation of the Montevideo Programme III and to consider elements for a future Montevideo Programme IV. The group of advisors will present their work at the end of November for further consideration and negotiation by the Governing Council of UNEP.

Prof Loretta Feris was also recently appointed to the Teaching Committee of the World Conservation Union (IUCN) Academy of Environmental Law. She is also a Law Commissioner of the IUCN.

## Pan African Parliament involvement

Mr Tshepo Madlingozi from the Department of Legal History, Comparative Law and Legal Philosophy and the Dean, Prof Christof Heyns, have on a number of occasions acted as resource persons for the Pan-African Parliament (PAP) Sub-committee on Rules, Privileges and Discipline. On these occasions

they presented background papers focusing on the harmonisation of laws on the African continent.

Mr Madlingozi was invited to a meeting hosted in Botswana in March by the PAP and the SADC Parliamentary Forum to present a paper entitled 'The role of PAP and regional Parliamentary bodies in the harmonisation of laws and policies in Africa'. He has also presented a discussion document to the PAP sub-committee on Peace and Human Rights.

Prof Stefan van Eck from the Department of Mercantile Law was invited to present a series of lectures on labour law at the Université Paris I – Sorbonne.

Prof van Eck taught as a group of 20 South African students, who had been selected to participate in a one year full-time Master's degree programme. The students were selected from a pool of South African applicants who have acquired more than 5 years working experience after having obtained their engineering degrees. The course administrator, Mr Francois Morvan, says that this teaching initiative emanates from a joint project between the South African and French governments to train a group of elite South African engineers, who after the completion of their studies in Paris and their return to the African continent, will hopefully become the future managing directors of engineering firms in South Africa.







#### Christof Heyns appointed as Fellow at Oxford

Prof Christof Heyns has been appointed as Visiting Fellow at Kellogg College, Oxford University for a two-year period. He has also been teaching in the Master's Programme at Oxford for a number of years and has been reappointed to this position in the University for 2008. He teaches and coordinates the Comparative Regional Human Rights Systems at Oxford, which is part of the Master's of Studies of Law Programme and which is attended by students from all over the world. According to Prof Heyns: 'There is no reason why the best and brightest students from our Faculty cannot excel in programmes like these. We as a Faculty should set ourselves the task of producing a Rhodes Scholar within the next five years.'

Prof Heyns has been reappointed for 2008 as Adjunct Professor at the George Washington School of Law of the American University in Washington DC, where he has been teaching for seven years.

#### Master's students visit Rwanda, Sierra Leone and Somaliland

Every year, the 30 students on the LLM (Human Rights and Democratisation in Africa) Programme of the Centre for Human Rights visit places of interest to their course on the African continent. This year, in March, ten students went to Rwanda, ten to Sierra Leone and ten to Somaliland.

#### Rwanda

The students who went to Rwanda visited Parliament to attend sessions; they visited embassies and in Kigali, the capital of Rwanda, they had discussions with the Gacaca Court Secretariat. They also visited the University of Butare and met the Vice-President of the Human Rights Commission.



#### Sierra Leone

The main event of the trip to Sierra Leone was when the students visited the Special Court in Sierra Leone (SCSL). They also had a meeting with Justice Itoe, Chairperson on the Legacy Working Group of the SCSL, as well as the Chief Justice for Sierra Leone, Dr Ade Renner-Thomas.

#### Somaliland

Somaliland used to be a part of Somalia but declared independence in 1991 after a devastating war waged by the troops of former Somali President Said Barre.

The students were accompanied by a visiting professor to the Centre for Human Rights, Dr David Padilla, Adv Fritz Gaerdes and Adv Jacob van Garderen (from Lawyers for Human Rights), Ms Susan Precious (Programme Manager) and Mr Martin Nsibirwa (LLM Programme Manager).

Some of the highlights included a briefing by the Ministers of Justice and Education of Somaliland. They were also addressed by the Vice-Chancellor of the University of Hargeisa, Prof Elmi Haybe Abdi.

### Inaugural address

#### Head of Public Law delivers inaugural address

Prof Christo Botha, Head of the Department of Public Law, delivered his inaugural address in October 2007. The title of his address was 'Failed states, fading dreams and a failing constitutional democracy: The (critical) role of public law academics'.

In his address Prof Botha argued that thirteen years after South Africa's transition to a constitutional democracy under a supreme constitution, the role of public law academics must be based on substantive and fundamental critical reflection, which should not be conflated with reactionary criticism based on political convictions, personal predilections or popular perceptions.

In a continent abounding with failed states, public law academics must increasingly enter into a substantive critical discourse about fundamental constitutional law issues, in the process addressing the spectre of the

South African state adorned with external value-laden constitutional symbolism, but with a crumbling democratic core. However, such a critical discourse also imposes the obligation of constructive engagement in an effort to address at least some of the problems. 'All legal academics are necessarily involved in the public law domain. Their crucial role is fostering a culture of respect for the rule of law, leadership and constitutional accountability amongst the lawyers and judicial officers of the future' he said.

Faculty raises admission

requirements for new LLB students

The Faculty Board decided to raise the admission requirements for new LLB students. Prof Melanie Roestoff from the Department of Mercantile Law, who chairs the LLB Committee, submitted the proposal to the Board in April 2007. The new admission requirements will be implemented in 2008 for the 2009 student intake.

Under the old system all students with a minimum M-score of 14 who applied before the end of September of the preceding year were automatically accepted into the LLB. Under the new system preference will be given to students with a minimum M-score of 18 (or the equivalent score under the new Admission Point Score system). These students will be accepted upon application until July, after which students with lower scores - to a minimum of 14 - will be admitted.

In addition to the above, new students are required to provide a letter of motivation, setting out why they want to study law and also why they want to study law at the University of Pretoria.

### UP hosts launch of Forum of Editors of Law Journals

The editors of most of South Africa's academic law journals recently met at the Faculty of Law to form the Forum of Editors of Law Journals. This launch was initiated by the South African Law Deans Association (SALDA), which asked the Faculty of Law to be the host of the inaugural meeting

The editors of 19 journals met to discuss ways to contribute towards enhancing, in the long run, the quality of legal publishing and also to act in a pro-active way to ensure that the unique nature of legal research is understood in the broader research environment. Prof Johan Mouton, from CREST at the University of Stellenbosch, gave a bibliometric overview of legal journals, as seen in the context of academic journals in South Africa and internationally.

The Forum will look at a number of issues, including a code of good practice for legal journals. Its first meeting will be held at the University of Pretoria in January in 2008, during the Law Teachers Conference.



#### Graduation

#### Chaskalson honoured

During the Winter Graduation Ceremony of the Faculty of Law, former Chief Justice Arthur Chaskalson was honoured with the LLD degree (Honoris Causa).

According to commendation, Judge Chaskalson was not only entrusted with building and strengthening the first Constitutional Court of South Africa, but he was also instrumental in shaping the constitutional dispensation in which this court could be established.

The honorary Doctorate was awarded to pay tribute to him as a jurist and exceptional human rights advocate. Judge Chaskalson remains actively involved in legal issues world wide, in doing the work of the International Commission of Jurists, an Institute of the Constitutional Court.

In the past, the Faculty has awarded honorary doctoral degrees to former Chief Justice Ismail Mahomed and the former President of South Africa, Mr Nelson Mandela.

#### Moot courts

#### African Moot Court Competition in Senegal

In August, the Sixteenth African Human Rights Moot Court Competition was presented by the Centre for Human Rights at the Université Gaston Berger, Saint-Louis, Senegal. Over 70 universities from across the continent participated in this year's competition.

Over the last 15 years, 708 teams from 111 universities in 43 African countries have participated in the Competition held in 13 different countries on the continent. The Moot Court Competition has become one of the most useful mediums for contact and exchange between law students, academics and judges from all over Africa in African human rights issues and debates.

The Moot Court Competition brings together law students, academics, judges and human rights experts from all over Africa to argue and debate a hypothetical human rights case in a mock courtroom. Each university is represented by two students and the human rights lecturer. Separate preliminary rounds were held in English, French and Portuguese.

Several renowned international jurists served as judges in the final round and simultaneous interpretation was provided.

The Faculty will host the SA Intervarsity Mock Trial Competition during 2008.

#### International Law in Domestic Courts Online Service

The International Law in Domestic Courts (ILDC) Online Service of Oxford University Press gives access to cases from domestic courts around the world dealing with all aspects of public international law.

Students and alumni of the Faculty of Law have contributed to the ILDC Online Service, especially in respect of Africa. The service currently includes cases from 10 African countries.

The cases are easily searchable in a rapidly expanding database which currently covers more than 65 jurisdictions. The ILDC Online Service includes summaries and the full text of the cases in the original language. For judgments in languages other than English relevant parts are translated. Brief commentaries put the judgments in context. The ILDC Online Service is a unique source of information for research and litigation in the field of international law.

Prof Christof Heyns, Dean of the Faculty of Law, is a member of the ILDC Editorial Board and Mr Magnus Killander, researcher in the Centre for Human Rights, is the ILDC Associate Editor responsible for Africa. Oxford University Press has recently agreed to make this service available free of charge to the Faculty.

### Publications

#### **PULP** non-fiction

The Faculty of Law is perhaps the only faculty in the country with its own publishing house. The Pretoria University Press (PULP) publishes scholarly works on law not in the first place intended as textbooks or practitioner's reference works, hoping to stimulate the publication in book form of high-level critical and theoretical engagements especially with African law.

PULP has published seven such scholarly works, with three more due in 2007 and two early in 2008. PULP publishes collections of primary legal documents from Africa - legislation, case law, and regional legal instruments and a series of discussion pamphlets aimed at generating and reflecting public debate about issues of concern within the university context. In 2008 PULP will launch a law journal entitled The Constitutional Court Review.

#### Recent PULP publications

- The Centre for the Study of AIDS and the Centre for Human Rights at UP, in 2006 engaged in a research project to give a voice to Southern African perspectives on issues pertaining to HIV, AIDS, law and human rights. Four researchers were selected to address issues of increasing importance in the context of HIV and AIDS in the sub-region. The publication, Human rights under threat: Four perspectives on HIV, AIDS and the law in Southern Africa with Prof Frans Viljoen, Director of the Centre for Human Rights and Ms Susan Precious from the AIDS and Human Rights Research Unit as editors, brings together their papers, provides an introduction, and includes some useful SADC instruments. An independent peer review of the papers was done before publication.
- The application of the doctrine of a loss of a chance to recover in medical law by Pat van den Heever, practising attorney in Cape Town is the first ever major work dealing with the application of the doctrine of a loss of a chance in medical negligence matters in South Africa.
- Another book recently published by PULP is Law, memory and the legacy of apartheid: Ten years after AZAPO v President of South Africa by Prof Wessel le Roux from the Department of Public and International Law at UNISA and Prof Karin van Marie from the Department of Legal History, Comparative Law and Legal Philosophy at UP.

The first part of the publication focuses on the ability of law to institute and sustain a different politics of memory. In the second part of the publication the focus of the essays shifts from jurisprudential reflections on the politics of memory to more direct engagements with issues of reparation and restoration in the wake of past injustices.



PULP published the third edition of Compendium of Key human rights documents of the African Union edited by Prof Christof Heyns and Mr Magnus Killander in English and the first editions in French and Arabic. The Portuguese version is currently in production.





#### UNESCO launches book on poverty

In August this year the Faculty hosted a United Nations Educational, Scientific and Cultural Organization (UNESCO) book launch. The book, Freedom from poverty: Who owes what to the poor? is published by Oxford University Press.

Mr Pierre Sané, Assistant Director-General for Social and Human Sciences, UNESCO, delivered a public lecture at the launch.

#### Bekink in committee position at International Bar Association

Dr Bernard Bekink from the Department of Public Law is currently the Senior Vice Chairperson of the Public Law Committee of the International Bar Association (IBA).

The IBA is the principal organisation of international law societies, legal practitioners and bar associations. Since its founding in 1947 the IBA has contributed to legal development on a global scale.

The IBA has three main objectives, namely the encouragement of international legal information exchange, support for the principle of trias politica and the freedom from interference in the legal field and support for human rights. In addition, various publications and symposiums supply the necessary network opportunities for legal practitioners. This also provides improvement of proficiency that is known to be unrivalled, in particular: the Public Law Committee (PLC) falls under the Legal Practice Division of the IBA and is mainly aimed at addressing public law issues of international interest.

Dr Bekink has been a member of the PLC since 2004 and his aim is specifically to further the aims of the PLC on the African continent and to act as a mediator between African countries and the PLC in general.

#### Comprehensive book published on human rights in Africa

International Human Rights Law in Africa by Prof Frans Viljoen, the recently appointed Director of the Centre for Human Rights, is a comprehensive analytical overview of human rights law in Africa. The book, published by Oxford University Press, examines the institutions, norms and processes for human rights realisation provided for under the United Nations, the African Union, and sub-regional economic communities in Africa, and explores their relationship with the national legal systems of Africa states.

Three cross-cutting themes are followed throughout the book: national implementation and enforcement of international human rights, legal and other forms of integration, as well as the role of human rights in the eradication of poverty. The book also provides an introduction to relevant human rights concepts.

#### Book explores employment contracts

The Employment Contract and the Changed World of Work by Prof Stella Vettori from the Department of Mercantile Law was published earlier this year by Ashgate Publishing Limited in London. The world of work has undergone major changes in the last two decades. The book examines these changes in their international context.

According to Prof Chris Nagel from the Department of Mercantile Law, 'This book is a much-needed addition to the literature on labour law, both in South Africa and abroad. The subject is very topical both in the national and international context.'

The view of Mr Justice Landman of the High Court of South Africa is: "How is the contract of employment to remain relevant in the changed world of work? Stella Vettori brilliantly shows that the implied duty of good faith is the ideal vehicle for adapting the contract to changing conditions."



#### Publication deals with the principles of medical law

Foundation Principles of South African Medical Law by Prof Pieter Carstens from the Department of Public Law, and Ms Debbie Pearmain, is the first textbook to thoroughly debate the Foundational principles of medical law in context of the South African Constitution.

The publication offers an authoritative text on the South African health care system; the regulation of the medical profession in South Africa; the legal basis of the doctor-patient relationship relating to the law of contract; the patient's privacy and medical confidentiality and many other issues.

#### Principles of local government in the spotlight

Principles of South African Local Government Law, by Dr Bernard Bekink, serves as a guide to obtain insight into local government and its functions.

The book explains the current legal dispensation of South African Local Government and underpins the municipal system's compliance with constitutional obligations. It also elucidates the local sphere's role in the system of co-operative governance and describes the local government's duties and responsibilities. The book aims to provide structure to the local sphere's legal dispensation.

Principles of South African Local Government Law provides information to the reader regarding the normative principles that form the basis of local government's legal dispensation, staffing matters, municipal finance, municipal public administration, the role of traditional leaders in the local sphere, and many more.

Reference is simplified with plain language that complements better understanding of this field of law.



#### IACL provides forum to constitutionalists

Mr Norman Taku, from the Centre of Human Rights, is the Deputy Secretary-General of the International Association of Constitutional Law (IACL).

Mr Taku's responsibilities are the general management and administration of the IACL, including the preparation and follow-ups of bi-annual Executive Committee meetings; coordinating all memberships (over 200 individuals, national associations and specialised institutes) including financial arrangements; shared responsibility for the regular update of the IACL website and English French translation.

The Secretary-General of the IACL, Prof Theunis Roux (Director of the Constitutional Court Institute, SAIFAC) is also co-editor of Constitutional Law of South Africa with Dr Stu Woolman from the Department of Public Law. Several graduates of the Centre's LLM in Human Rights and Democratisation programme are also based at SAIFAC.

The principal objective of the IACL is to provide a forum in which constitutionalists from all parts of the world can begin to understand each other's systems, explain and reflect on their own, and engage in legal comparison.

#### Focus on



#### Centre for Child Law presents case in the Constitutional Court

The Constitutional Court recently handed down judgment in the case of

M v The State (Centre for Child Law acting as amicus curiae).

The case dealt with an appeal by Ms M, a mother of three boys. She had been found guilty of fraud to the value of R19 000.00 and received a four-year jail sentence. On appeal this sentence was changed to correctional supervision to be served in the community, but Ms M was still required to serve one sixth of her sentence in prison.

She appealed to the Constitutional Court, arguing that the constitutional rights of her children had not been given sufficient weight at the time of sentencing.

The Court invited interested parties to appear as amicus curiae; literally 'a friend of the court', and directed that papers be served on the Centre for Child Law – virtually an invitation to get involved in the case.

The case was argued on 22 February 2007. Paragraph 6 of the judgment by Justice Sachs reads as follows: 'The Centre for Child Law of the University of Pretoria was admitted as amicus curiae and Ms Skelton made wide-ranging written and oral submissions on the constitutional, statutory and social context in which the matter fell to be decided.'

#### Re-building the Faculty

The Building Committee of the Faculty initiated renovations of the building related to problems such as rising damp and new initiatives such as the zebra crossing in front of the building. During this, the entire building was repaired and currently the waterproofing of the Library is being re-done.

#### Faculty plan submitted

The new plan for the Faculty of Law was submitted to the University Executive by the Dean and the Heads of Department in September. Previously the draft plan was discussed with various stakeholders in the Faculty, and it will be discussed at length with the Faculty at a strategic session in January.

The ambitious and comprehensive plan covers the period from 2007 to

2010, and provides for renewal in the Faculty on many fronts. This includes the greater internationalisation of the Faculty, and a stronger focus on post-graduate work. A part of the plan that was particularly well-received was the introduction of a full-time doctoral programme, catering for 30 students from around the world.

According to the Dean, Prof Christof Heyns: 'We are uniquely placed at the Faculty of Law. We can improve an excellent institution even further'.

#### Law of Africa Collection

The Oliver R Tambo Law Library is home to the world's largest collection of the Law of Africa. The Library collects primary sources (legislation and law reports) from as many African countries as possible in order to facilitate research into the legal systems of Africa. The library has already built up a reasonable collection, which contains material on most of the SADC countries, as well as many other African countries. The material is available in paper format or in electronic format (CDs).

A database of citations to the law reports of African countries is also in the collection, containing over 9 000 records. The database may be used to find specific cases or to search for cases on specific topics. All of the judgments are kept in the collection of the law library.

'Material from African countries can be very difficult to gather. A donation from the Open Society is enabling us to broaden the collection by fetching material that would otherwise be impossible to collect. On a recent trip to Lesotho we collected a set of the Laws of Lesotho from 1960 to date, as well as the new law reports for that country', says Ms Shirley Gilmore of the Oliver R Tambo Library.


## UP and UJ law faculties meet


Student involvement in debates, most courts and research projects is important as Law House agrees to create a tradition of being the top debaters - not only in Africa.
